MINUTES OF THE MEETING OF NAC 4 & 4A (METAL PRODUCTS) - PERIODIC CONSULTATION WITH SECTORAL ASSOCIATIONS CONVENED BY THE CONVENOR OF GROUP 4 & 4A (METAL PRODUCTS) / CHIEF COMMISSIONER OF CUSTOMS, AHMEDABAD ZONE, HELD ON 10.06.2026 AT 15:30 HOURS.
